# Proposed Acquisition of Iowa Veterinary Specialties, P.C.

Vice President Warren Madden briefed the Board on the proposed acquisition. At President Miles' request, College of Veterinary Medicine Dean John Thomson elaborated on the educational motivation on the proposed acquisition.

- ➤ MOVED by EVANS, SECONDED by CAMPBELL, to consider the following actions requested by Iowa State University related to the acquisition of assets of Animal Emergency Clinic, PC d/b/a Iowa Veterinary Specialties, PC (IVS) for the amount of \$4.56 million, and authorize the operation of IVS through a non-profit entity (Iowa Veterinary Services Corporation) affiliated with the University:
  - Approve the University's request to purchase real estate located at 6110 and 6120 Creston Avenue, Des Moines, Iowa 50321 from IVS at the price of \$1,550,000, and approve the University's proposed financing plan for the purchase of the real estate and business assets (\$3,010,000) of IVS.
  - Approve the Restated Articles of Incorporation and By-laws of Iowa State University Equities Corporation, and authorize the Executive Director of the Board of Regents and Iowa State University to take actions necessary to adopt the restated Articles of Incorporation and Bylaws and to execute the Real Estate Lease.
  - Delegate to the University the authority to execute the Asset Purchase Agreement, Affiliation Agreement and Repayment Agreement.
