Executive Summary: The University requests approval of a revised project description and budget of \$7,742,000, an increase of \$442,000, for the **Jeff and Deb Hansen Agriculture Student Learning Center** project. The revised project budget includes additional funds from Private Giving and University Funds. The facility, currently under construction, includes a 125-by-250 foot arena which will be used for teaching, livestock judging, skills competition, short courses, training sessions, and shows. Four classrooms are also included in the facility, which would enhance interaction with animals, education and outreach in animal agriculture, helping to ensure a strong animal agriculture workforce.
