As a young person who grew up and currently lives and works in rural lowa, I was extremely disappointed to hear the action that was taken by the ISU Extension and Outreach Program and the Board of Regents concerning the Extension Restructuring Plan. In today's economy, we all understand that budgets are tight and priorities must be identified, but making sound decisions for the future of lowa and its citizens is paramount.

I am writing this letter because I directly benefited from outreach programs funded through ISU Extension, am active in rural grassroots organizations within our state, and am taking an active role as a young farmer and community member in Audubon, IA. While in high school, I served as President of the Adair County Youth Action Committee, received a State 4-H Citizenship Project Award, and attended National 4-H Congress in Atlanta, GA, all as a result of my 4-H involvement. During my tenure at lowa State University, I served as a State FFA Officer, was President of the Collegiate 4-H Club, was a four year recipient of the lowa Farm Bureau Federation Scholarship, served as co-chair of the College of Ag Student Ambassador Program, and was selected by my peers as "Ag Man of the Year" in 2004. Since earning my B.S. degree, I have been elected to serve on the Audubon County Extension Council, competed in the American Farm Bureau Young Farmer Discussion Meet, attended numerous area extension educational seminars, and was recently selected to serve on the Iowa Farm Bureau Young Farmer Advisory Committee. Call To Action: At the next State of Iowa Board of Regents meeting, June 10-11, 2009, open a discussion to consider and take action on alternatives that were not originally brought to the table regarding the Extension Restructuring Plan brought forth in May 2009 (i.e. – reduced hours, furloughs, etc.).
